La Clinica Aims to Improve Care with JHIE

La Clinica del Valle Family Health Care Center, also known as La Clinica, offers services through six neighborhood health centers, nine school-based clinics and a mobile health center. Joining JHIE to improve patient care was a logical step for the organization.

"We want to be able to connect to our partners in the community for faster and more accurate service for our patients," said Rebecca (Becki) Platts, medical assistant at La Clinica Birch Grove. Before JHIE she communicated over phone and fax but now JHIE makes referring patients to specialists easier and accessing clinical reports for their patients much faster.

Referring to the JHIE Community Health Record, which she mainly uses to access reports for providers, Platts said, "The ease of being able to find hospital records and reports is a

Behavioral Health Data Exchange Update

JHIE continues to work toward integrating behavioral health information into the Community Health Record. With a clear understanding of applicability of the law, the team has been meeting with EHR vendors that support substance use treatment providers to understand their capabilities for passing patient consent to JHIE. Additionally, a common consent form is being developed in collaboration with the Oregon Health Authority. This form will comply with all 42 CFR Part 2 informed consent requirements and serve to support a release of information for both electronic and paper-based records sharing.

The Behavioral Health Workgroup has been meeting to define workflow processes to support electronic exchange supported by a patient consent. Over the coming months, the technical specifications for sharing behavioral health records will be finalized and JHIE will be providing guidance to interested provider organizations.

Veteran's Administration Connectivity

Soon, a patient search in JHIE will give users the option to query the US Veteran's Administration (VA) for a care summary on their patients who also receive care from VA health care facilities.

JHIE has been working with the VA to build connectivity through the eHealth Exchange.

Advantages to Connecting your EHR with JHIE

Are you on a payor panel that requires you to report on quality metrics? JHIE can help!

By connecting your EHR to JHIE and contributing CCDs to the community, JHIE is able to pull the required quality metrics out of your CCD data and send it to the CCO(s) or other payors taking that burden off of you and your staff. Having access to this information on their members can also reduce the payors' need to do chart audits in your office - saving you time and money.

Connecting your EHR to JHIE also can improve clinical productivity, help meet CMS requirements, and help better care for patients without ever having to leave the clinical record. With a JHIE interface, users can:

- View the lab results and reports for diagnostics performed on your patients, including those ordered by other providers.
- Send a Continuity of Care Document (CCD)/clinical summary to the JHIE community, where other providers caring for your patient can view information without having to call your office for the information or repeat tests on your patient.
- Query the JHIE Community Health Record right from the patient's chart in your EHR to understand who else is caring for your patient and what information they have made available for you to better care for your patient.
- Coordinate care when your patients are discharged from the hospital, helping you to meet CMS requirements for transitions of care.
- Communicate via secure messaging with other providers in the JHIE network as well as those in other "Trusted" Direct messaging networks.
